I. Call to Order

II. Minutes

After reading the minutes from the prior quarterly meeting held by the Board of Directors on January 8, 2017, Brother Sawyer motioned for the approval of the minutes. Brother Will seconded the motion. The motion passed unanimously, approving the minutes.

VP of Membership – Joshua Sawyer

VP of Compliance – Gregory Will

- A. Attended a pre-sanction conference on March 1, 2017 regarding alcohol abuse by the Active chapter at Spring 2017 Bid Day. A young woman who was with the Active chapter and wearing a DU shirt during Bid Day events consumed too much alcohol and went to the hospital.
 - The Active chapter has been suspended from hosting any alcohol related events this semester, must attend an alcohol awareness training, and pay a \$500 fine to Greek Life
 - They are also suspended from participating in Fall 2017 Bid Day festivities, but can still recruit and have a pledge class
