- 2) Membership Eligibility (Article II, Section 1) Need to settle on a rate structure for membership dues. Discussed whether or not to specify a rate directly in the bylaws, or if the rate should be left variable, with the option to adjust as needed.
- 3) Ouorum (Article III, Section 4) Discussed and made revisions.
- 4) Election of Directors (Article IV, Section 4) Discussed and made revisions.
- 5) Powers (Article IV, Section 8) Discussed and made revisions.

- B. Plan is to solicit as many alumni as possible to attend the October meeting to go over the proposed Bylaws and vote/approve the Bylaws. President Esposito will send out an email to the alumni, and also post a message in the Alumni's Facebook Group.
- C. Chapter Payments
 - 1) Discussed how to approach and talk to the undergraduate chapter about payment of the loss prevention insurance premium.
 - 2) Discussed some options for receiving payment(s) from the chapter.
 - 3) Brother Koen motioned that the new rate for loss prevention insurance premium be set at \$525 annually, Brother McCaghren seconded the motion. No With no opposing votes or abstention, the motion passed unanimously.
- D. General advising to the Undergraduate Chapter
 - 1) Discussed the Foundation's role in advising the Undergraduate Chapter, not just monetarily, but also working with them with education, career, planning, etc.
- E. Discussion of having 2016 Turkey Bowl at AT&T Stadium
 - 1) Brother Esposito expressed some concerns about having the 2016 Turkey Bowl at AT&T Stadium. Several discussion points followed; the Foundation Board will follow up with the Undergraduate Chapter on this issue.
